  - Peer Jury sessions begin promptly at 6:00 P.M. and are usually over by 8:30 P.M.
  - It is essential that a Peer Juror attend as many meetings as possible. When jurors fail to attend, the program runs the risk of not having enough jurors to hear the evening's docket of cases.
  - If a peer juror is not able to attend a Peer Jury meeting, the juror must notify the Teen Court Coordinator or other designee, as far in advance of the absence as possible
- A peer juror who misses three meetings without first notifying the Teen Court Coordinator or other designee will be removed from the Peer Jury
